5. ENTRIES & ENTRY FEES

5.3. Entries for this Event shall close at 0900hrs (AEST) on Wednesday 14th May 2025.
The completed Entry Form must be received no later than this time.

5.8. Entries for Friday Practice may be accepted for Automobiles not complying with the Categories listed for the event, provided they can be matched to a suitable running group as per the CRSR.

8. CREDENTIALS & ACCREDITATION

8.1. Each competitor shall receive 6 passes per entry.

8.2. Passes shall be available to competitors who are in attendance on Friday 16th May at the Administration Office. All other competitors shall be issued their passes at Driver Briefing.

9. ACCESS TO THE CIRCUIT

- 9.1. Please note that there is no access possible prior to the times listed below.
Access to the Circuit shall be available from 0700 hrs on Friday 16th May for those entered in Private Practice, and Friday evening from 1600 hrs to **1730 hrs** for those not entered in Private Practice.

The gates shall open again at 0700 hrs on the Saturday.

12. DOCUMENT CHECK AND SCRUTINY

- 12.1. ~~Document~~ **Licence** check shall be completed electronically unless otherwise organised with the Secretary of the Event. **Proof of Club Membership, Self Scrutiny Documents and Vehicle Logbooks shall be presented at Driver Briefing Sign-on.**
For those participating on Friday, Proof of Club Membership, Self Scrutiny Documents and Vehicle Logbooks shall be presented at the Administration Office prior to participating at the time listed in the Friday Schedule.

15. EVENT SCHEDULE

15.2. The Event Schedule may be varied or altered at the Promoter/Organiser's discretion, with the approval of the Stewards. You shall be notified of any changes.
15.3. The Promoter/Organiser reserves the right to abandon or cancel the Event or any part of the Event in accordance with the NCR.

24. PRIVATE PRACTICE

- 24.1. The Circuit shall be available for pre-event practice on Friday 26th May.
24.2. The Organiser for the weekend race event is PIARC, as is the Friday.
24.3. A separate Entry Fee is payable to the Organisers for the Friday sessions.
24.4. Entry is Preferred via Motorsport Australia Event Entry – **Entries for Private Practice will be accepted until 1700hrs (AEST) on Thursday 15th May 2025.**
